

REFRIGERATION & SUSTAINABILITY

Sustainability has been in the news a lot lately with all the focus on reducing greenhouse gases. One of the areas of focus has been refrigerated facilities. Refrigerated facilities are just one of the components of the cold chain responsible for preserving food products from the point of production to the point of delivery to consumers. Aldi grocery stores are one of the players that have been in the news. They have been transitioning stores from hydroflourocarbons (HFCs) to natural refrigerants (CO2) in hundreds of stores. HFCs are 1,400 times more potent than carbon dioxide as a greenhouse gas.

If you are interested in learning more about designing refrigerated facilities or the refrigeration systems they depend on check out <u>ASHRAE's guide for Sustainability in Refrigerated Facilities, Refrigeration Systems</u>.

There are two very important opportunities for chapter members to help improve the building and energy code process in Oklahoma right now:

- 1. Please reach out to your state House of Representatives members and ask that they support SB148. The ask of this bill is to increase the number of members on the Oklahoma Uniform Building Code Commission (OUBCC), the commission that makes recommendations to the legislature regarding building code updates and adoption. This bill is aimed to provide the commission with members who are licensed by the state as mechanical and electrical engineers. They have experience and knowledge of design and code compliance that is needed on the commission based on its current make up. The bill was passed out of Senate committee unanimously and then passed the Senate 44-3. We now need to reach out to our Representatives to ask for them to support this bill in the House.
- 2. There is an opportunity to volunteer to sit on the committee that will evaluate the 2015 IECC update and adoption. It is important to have ASHRAE members familiar with the energy codes participate in these discussions. There is a specific slate of roles identified for membership, including a mechanical engineer and a commercial mechanical contractor. 






HISTORY By Gene Redford
