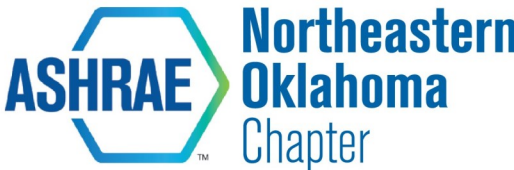

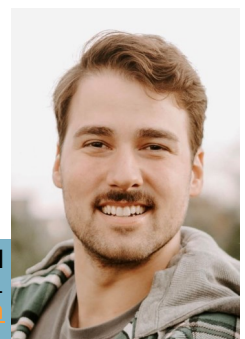

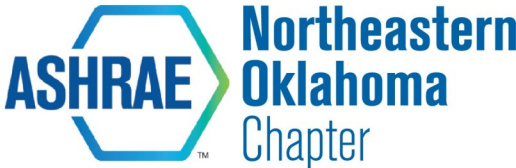

GOVERNMENT AFFAIRS

Happy New Year! As each new year starts, everyone starts over with their new plan and goals for the coming year. GAC activities this year will be no exception.

When we have our discussions about ASHRAE and the HVAC industry with elected officials, we always highlight some facts about the HVAC industry's impact on the economy in the State of Oklahoma. They include:

- Total economic output from the HVAC industry in the state of Oklahoma ranks #9 in the US.
- Total number of jobs directly related to HVAC industry is over 22,000, ranking Oklahoma #15 in the US.
- One study showed 1 out of every 84 jobs in the state of Oklahoma civilian labor force is in the HVAC industry. This ratio ranks Oklahoma a #2 behind only the state of Texas.
- In the last 5 years, HVAC manufacturers have invested well over \$ 400 million in new facilities and renovating/repurposing existing facilities.

We look forward to our coming opportunities to meet with municipal and state leaders and will be sending out communications for members to be able to participate in the meetings as they are scheduled.

Also, a reminder that February 18-24th is National Engineers week. ASHRAE will be securing a Mayoral Proclamation recognizing the week along with NEOK ASHRAE's efforts to promote the HVAC industry and STEM education. We will be working with Student Activities as well as our public offices to promote growth in these areas.

That leads us into the upcoming annual Outreach visit to the State Capitol soon. We are settling in on a day in March and will be spreading the word, but I encourage you all to plan on joining us. It is a great day to connect with your legislators and promote ASHRAE and the HVAC industry.

Lastly, any time you find yourself speaking with public officials at the municipal or state level, don't forget to remind them of the ASHRAE certification programs that are available to anyone. 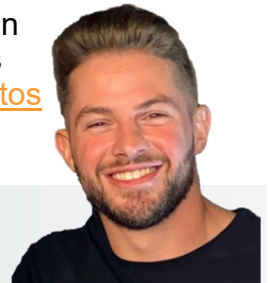

History of NEOK Chapter Hall of Fame – Part 1 (Part 2 in February 2024 will include year's 2021, 2022, 2023 and the 2024 HOF Inductee)

- The Hall of Fame Award was established in 2018 with the first class inducted in 2019—Annual nomination (s) are entrusted to the Honors & Awards Committee - Nominees are approved annually by the current Officers and BOG.

2020 Hall of Fame Inductees



Norm Asbjornson - After a tour of duty in Korea with the Army, he graduated from Montana State University with a degree in Mechanical Engineering in 1960. After 28 years working in the HVAC Industry, Norm founded AAON in 1988 by purchasing the HVAC division of John Zink Company. Norman's goal was to create a commercial HVAC company that would design and manufacture semi-custom equipment which would excel in performance relative to the marketplace. Starting in Tulsa, OK, AAON has now expanded manufacturing to 3 additional sites with a collective 2,832,000 S.F. and close to 4,000 employees. AAON has been a major contributor to ASHRAE, beginning contributions to ASHRAE Research Promotion in 1993 and in 2000 they became a Golden Circle Contributor at \$10,000. In 2013 they stepped that up to Platinum Circle Contributor at \$20,000. They support their employees in service to ASHRAE with many serving in leadership roles on Local level as well as Regional and Society levels. AAON has always stepped up to sponsorships to NEOK ASHRAE events through the years.



Gene Redford served as the chapter **fiftieth President in 1998/99**. Gene joined ASHRAE in January 1968 while working for Jack Tumilty with Collins Engineering Co. After graduating from Tulsa Central High School Gene served in the US Army, stationed in Germany from 1959 to 1962. He worked for Jack from 1962 to 1973 and joined Natkin & Co. as a project manager. In 1979 Gene joined Natkin Service where he stayed until 1994. He rejoined Natkin Service as District Service Manager until he retired in 2005. In 2007 Gene went back to work and joined McIntosh Service as an Account Manager. Gene has been involved in the NEOK chapter in many positions over the last 47 years. He received the chapter service award and was awarded the Golden Gavel his year as President.

2019 Hall of Fame Inductees



Chick Morse served as the chapter's **thirty-seventh President in 1985/86**. Joined Gulf Oil Company in 1952 after 4 years of military service. Joined Process Equipment Company, in sales, in 1966 through his retirement in 2000. He is NEOK's Chapter first Golden Gavel winner as chapter president. Chick's other awards include Chapter Service, Regional Award of Merit, Distinguished Service and Distinguished 50 Year Member Award. Chick served the Region as Alternate and Delete of the Society Nominating Committee. He also served on the Society Research Promotion Committee as Regional Vice-Chair and as Chair of the Committee.



R. F. Shoemaker Sr. was a charter member served as the **third President 1951/52**. Richard joined his father Forrest Shoemaker, in the air conditioning company in 1946 with a B.S. in Mechanical Engineering from Purdue University and obtained his P.E. in 1963. Richard's son Rick Jr. third generation is active in the family business still today. Richard has passed away.

Jack E. Tumilty served as the chapter eleventh President in 1959/60. This was the year ASHAE became ASHRAE and Region VIII was established. Jack graduated from OU in 1948 with a BSME and became a PE a brief time later. He moved around and worked for several companies before moving back to OKC and joined Collins Engineering & Associates in 1951. In 1952 Jack moved to Tulsa and opened the Tulsa branch of Collins, and later appointed as Vice President in charge of the Tulsa office. Jack served as chair for the ASHRAE Standard 90 from 1974 to 1980 and has received many awards including Distinguished Fellow, Distinguished Service, Regional Merit, Chapter Service, 50 year and life member. Our chapter established a Jack Tumilty Scholarship in his honor. Jack has passed away.

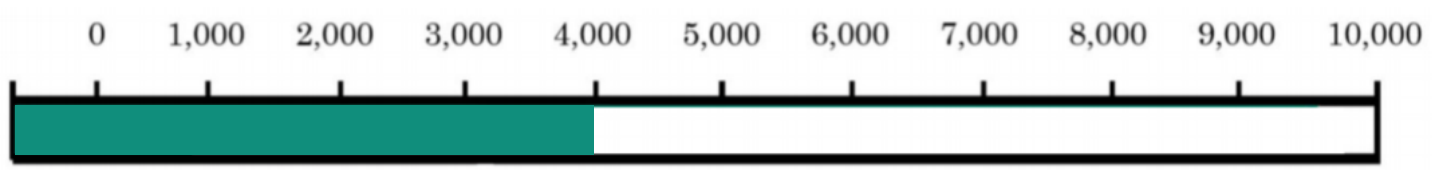
