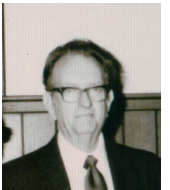


## NEOK ASHRAE chapter's presidents.



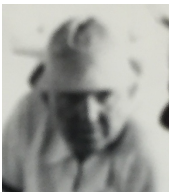

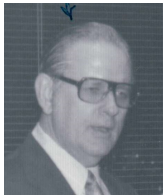

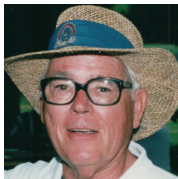
**Richard L. Herron** was the chapter **fifth-tenth president in 1963/64**. Dick first became active in the HVAC field in Kansas City in 1946, later joining the Trane Company in Tulsa in 1956. Dick started the Herron Equipment Company in Tulsa in 1969 and retired in 1985. His son Joe joined the company in 1973 and sold the company. Back then the meetings were held at the Saratoga Motel on seventh street and held the first joint meeting with Oklahoma City Chapter.
