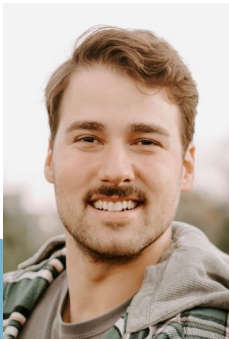
Our November ASHRAE meeting will be held on November 2nd. This coming meeting we’ll be celebrating our 75th anniversary, so they’ll be no presenter.

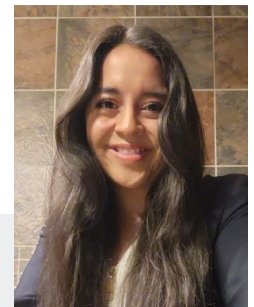

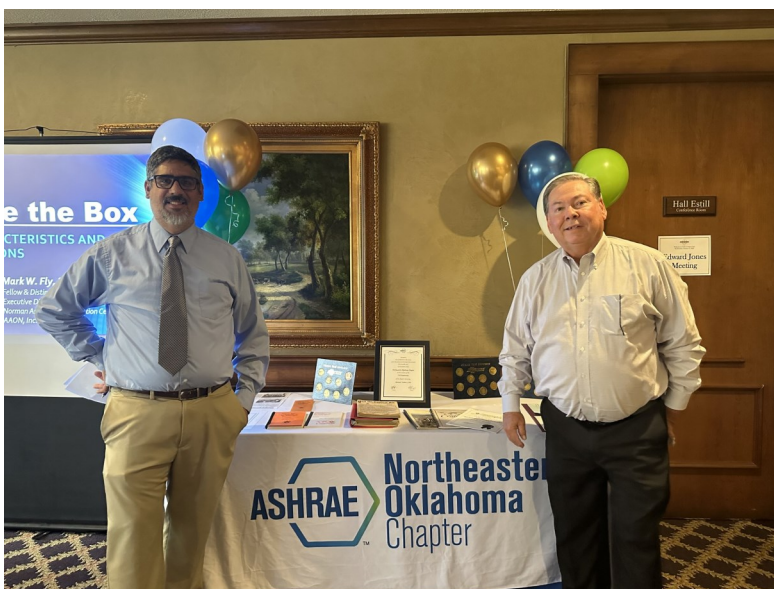

## HISTORY

### Transition Year for 2023-2024 History Committee

Northeast Oklahoma ASHRAE Chapter has a rich History dating back to the original charter. The Chapter was formed on October 4, 1948, with 25 members and led by W.R. Lee, 1<sup>st</sup> Chapter President. Fast Forward 75 years and Matt Simmons is currently serving as the 75<sup>th</sup> Chapter President with approximately 200 members. We acknowledged this milestone on October 4, 2023, at our monthly Chapter Meeting. We are planning a 75<sup>th</sup> Anniversary Gala at the Mayo Hotel, downtown Tulsa, on November 2, 2023. The ASHRAE Society President, Ginger Scoggins, will be present to join our celebration. Please come out and join the celebration.

Our Chapter has been blessed with several dedicated members who have stepped forward to serve as Chapter Historian. We can thank Fred Brandt, Pete Winget, Richard Shoemaker, Chick Morse, Jack Tumilty, Ron Spencer, Mike Thompson, Bob Allwein, and Gene Redford (along with many others who served as Historians or on History Committee).

Gene Redford has served as Chapter historian from 2009 to 2023 and has done a great job in collecting and organizing historical information and artifacts. Gene has decided to step back and turn over the duties of Chapter Historian to my care and preservation moving forward. Gene has graciously offered his ongoing support to me in those efforts in an advisory capacity.

Gene Redford joined ASHRAE in 1968 while working with Jack Tumilty at Collins Engineering Co. from 1962 to 1973. He joined Natkin & Co. as Project Manager in 1973. In 1979 Gene joined Natkin Service Co. until 1994 when he was promoted to District Service Manager from 1994 to 2005 when he 1<sup>st</sup> retired. In 2007 Gene decided to return to work at McIntosh Service as Account Manager until his 2<sup>nd</sup> retirement 2016. Gene has served the NEOK Chapter in committees and offices since 1969 to the present. He was the 50<sup>th</sup> Chapter President in 1998/99 and was awarded the Golden Gavel for being the best Chapter in Region VIII. Numerous other awards, too many to list here, along with attaining Life Member status.

Gene's accomplishments both in life and in service to the Chapter should be recognized and celebrated. I can remember back in the early 1990's I was a young project manager with Natkin & Co. when we relocated offices to the Natkin Service Co. offices. Gene was very encouraging to me in joining and getting involved with the NEOK Chapter. He suggested that I Chair the Attendance Committee to meet more of the membership and network with the industry professionals. I am thankful for that mentorship and endeavor to continue Gene's legacy of mentorship with the younger members in our Chapter.

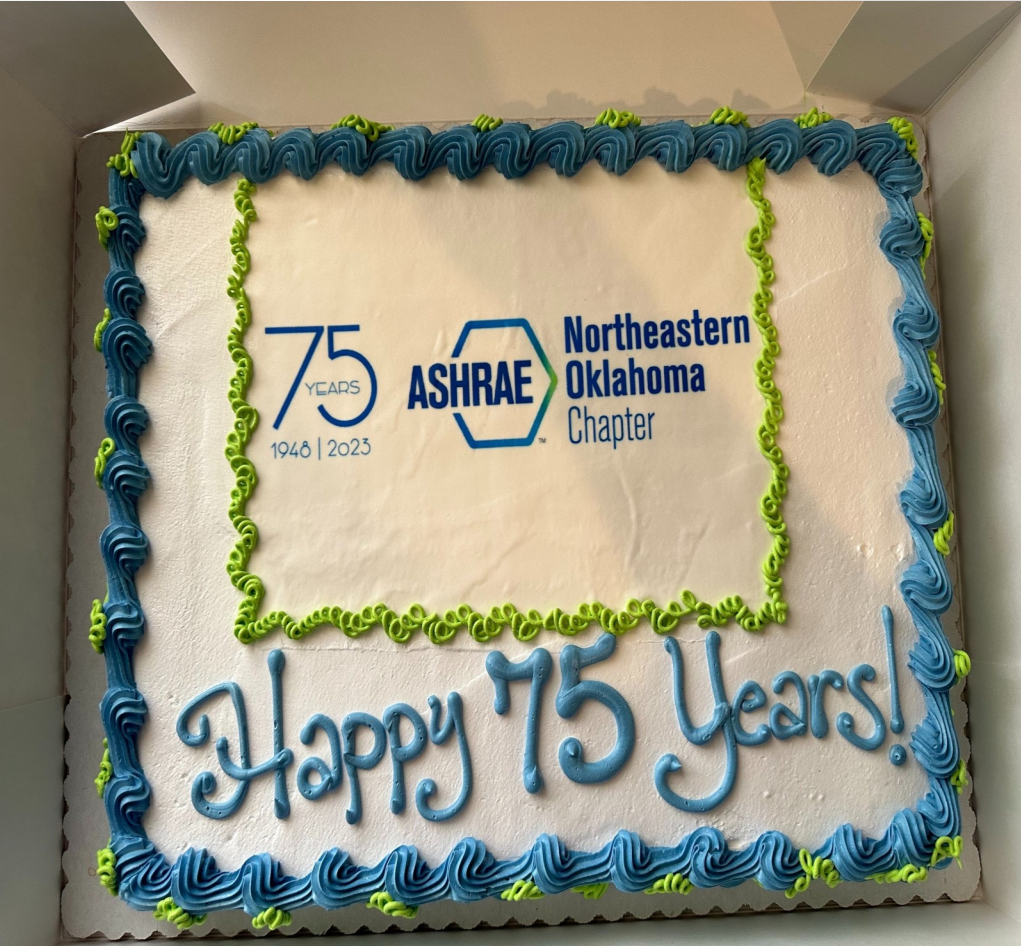
